

ORDER CALLING A TRUSTEE SPECIAL ELECTION

THE STATE OF TEXAS :  
COUNTY OF TARRANT :  
EAGLE MOUNTAIN-SAGINAW INDEPENDENT SCHOOL DISTRICT :

WHEREAS, this Board of Trustees deems it advisable to call the trustee special election hereinafter ordered; and

WHEREAS, it is hereby officially found and determined that said meeting was open to the public, and public notice of the time, place and purpose of said meeting was given, all as required by the Government Code, Chapter 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF EAGLE MOUNTAIN-SAGINAW INDEPENDENT SCHOOL DISTRICT:

Section 1. Findings.

The statement contained in the preamble of this Order are true and correct and adopted as findings of fact and operative provisions hereof.

Section 2. Election Ordered; Date; Proposition.

An election shall be held for and within the District on **May 6, 2017**, at which election for Board Trustee shall be submitted in accordance with law.

Section 3. Precincts and Polling Places.

The election precincts for the election, the polling places for such precincts on election day, and the date and hours for voting at the election are hereby established and designated in Exhibit A attached hereto, which is incorporated herein by reference and made a part hereof for all purposes.

Section 4. Early Voting.

The Main Early Voting Polling Place for conducting early voting by personal appearance, the dates and hours for early voting by personal appearance and the address for early voting by mail for the election are hereby designated as set forth in Exhibit A attached hereto.

Section 5. Election Officers.

The election officers designated by the Tarrant County Election Division are hereby appointed and confirmed to hold the election at the polling places. As determined by the Tarrant County Election Division, the Presiding Judges shall appoint not less than

two nor more than five qualified election clerks to serve and assist in conducting the election; providing that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks. An early ballot board is hereby created to process early voting results, and the individual designated by the Tarrant County Election Division is hereby appointed the presiding judge of said board. The presiding judge shall appoint at least two other members of the board. Frank Phillips, Tarrant County Elections Administrator, shall serve as early voting clerk for the election.

Section 6. Official Ballot.

The official ballot for said election shall be prepared in accordance with the Texas Election Code so that at said election votes may be cast for candidates seeking Board of Trustee position **Place 1**.

Section 7. Bilingual Election Materials.

The election materials enumerated in Texas Election Code, Section 272.001, et seq., shall be printed and furnished in both English and Spanish for use at the polling places and for early voting.

Section 8. Conduct of Election.

The election shall be conducted in all respects in accordance with the Texas Election Code, and all resident qualified electors of the District shall be entitled to vote at the election. Pursuant to the Federal Help American Vote Act and the Texas Election Code, each polling place shall be provided at least one voting system equipped for individuals with disabilities.

Section 9. Notice of Election.

(a) Notice of the election shall be given by (i) publishing a substantial copy of this Order in both English and Spanish one time not earlier than the 30th day or later than the 10th day before election day, in newspaper published in the District or, if none is published in the District, in a newspaper of general circulation in the District and (ii) posting a substantial copy of this Order in both English and Spanish on the bulletin board in the District's administrative offices used for posting notices of the meetings of the Board of Trustees of District not later than the 21st day before election day.

(b) Such notice, as posted and published, shall include and constitute a schedule stating the location of the temporary branch early voting polling places for said election, the election precincts served by the temporary branch polling places and the dates and hours that temporary branch voting will be conducted.


