The Certified Nursing Assistant program is designed to provide students with skilled training and preparation for the nursing profession. Students will develop skills to provide quality assessment and care for the patients. Students are required to participate in practical training at a local long-term care facility. Successful completion of this program will prepare the student for college courses in the medical field. Students must possess a social security card for testing and will be required to undergo a criminal background check and provide proof of a recent (6 months) TB test prior to practical training at the designated nursing facility.

### Transportation

Transportation will be provided to and from the home campus for daily classes at HCTC only.

**\*\*\*Transportation to the clinical site MUST BE PROVIDED BY STUDENTS. Students will attend clinicals from 6:00 am until 10:00 am, one day a week for 10 week. Attendance is mandatory and will count as a test grade. If a student is unable to attend a clinicals due to transportation issues, tardiness, or inappropriate behavior at the site, they will be in jeopardy of receiving a failing test grade, ineligibility to take certification exam, and the student may be removed from the class.**
