Course Description: Forensic Science

Forensic Science is a course that uses a structured and scientific approach to the investigation of crimes of assault, abuse, neglect, domestic violence, accidental death, homicide, and the psychology of criminal behavior. Using scientific methods, students will collect and analyze evidence through case studies and simulated crime scenes such as fingerprint analysis, ballistics, and blood spatter analysis. Students will learn the history, legal aspects, and career options in forensic science.

A parent or guardian will be required to sign a permission slip giving approval to view materials and discuss cases and evidence that are of a sensitive nature and not normally "school appropriate," but which fulfill the TEKS for this course. All such topics will be handled in a mature and respectful way.

Prerequisite: Biology and Chemistry

Forensic Science (5912) 1 period, all year; must take with Law Enforcement I, Law Enforcement II, or another HCTC course

Forensic Science-Accelerated (5911) 2 consecutive class periods, one semester; on HCTC campus

*This course fulfills the 4th year science graduation requirement.
