Course Description:

Advanced Automotive Technology is a course that builds on the knowledge and skills learned in the Automotive Technology 1 course. Students will learn how to operate in a service shop environment. They will improve their critical thinking process to diagnose and repair shop and customer vehicles. Students will develop the soft skills and the technical skills needed to keep up with the ever-changing automotive industry. Students are expected to complete the student ASE certification program. After successful completion, they will be encouraged to take the professional level G1 ASE Certification Test.

Transportation

EMS ISD provides daily transportation between HCTC and the home campuses.
