Course Description

This is a combined course which includes 50 hours of instruction in both Electrocardiogram and Phlebotomy. Students will learn the needed knowledge, skills, vocabulary, mindset and professionalism to be successful in the healthcare field.

ECG: Students will learn the “how and why” of applying, obtaining, and interpreting an ECG on both simulated and real-world patients. Upon successful completion of this course, students will be eligible to sit for the National Centers for Competency Testing (NCCT), Certified ECG Technician (CET) Exam.

Phlebotomy: Students will demonstrate tactile skill and practical knowledge which will allow them to effectively locate veins and obtain blood samples from both manikins and human subjects. Students will obtain the required minimum 25 successful venipunctures per NCCT requirements. Upon completion of this course, students will be eligible to sit for the National Centers for Competency Testing (NCCT), Certified Phlebotomy Technician (CPT) Exam.
