***Transportation to clinical sites MUST BE PROVIDED BY STUDENTS/PARENTS. Clinical rotation site visits will take place one week a month during their regularly scheduled clinical rotation class time and will count as a test grade. All students are expected to go on their clinical rotation site visits. If a student is unable to attend a clinical rotation due to transportation issues, tardiness, or inappropriate behavior at the site, they will be in jeopardy of receiving a failing test grade and the student may be removed from the class.

EMS ISD provides daily transportation between HCTC and the home campuses. Students may drive personal vehicles to and from HCTC with a signed parent/guardian transportation form and a proof of automobile insurance on file at HCTC. HCTC will issue no-cost parking passes after receiving both items. Students are not allowed to transport other students during the school day.
