Course Description

Practicum in Education and Training is a field-based internship program that is designed to provide students with the opportunity to demonstrate their understanding of child and adolescent development principles, as well as principles of effective teaching and training practices.

Students will be assigned to an EMS ISD campus and work under the combined direction and supervision of the course instructor, campus mentor teacher (field site teacher), and campus administration. Students learn to plan and direct individualized instruction and group activities amongst their field-site student population, as well as with their peer “professionals”.

Students will:

- Prepare instructional materials of their own design
- Assist with recordkeeping
- Make physical arrangements within the classroom setting, as well as to facilitate group activities
- Complete other appropriate responsibilities of a classroom teacher, trainer, paraprofessional, or other educational personnel

Students are encouraged to join their campus chapter of Family Career and Community Leaders of America (FCCLA) and compete in the Teach and Train Occupational Event category as a part of their documentation of coursework.

Transportation

-Students/Parents must provide transportation to and from field-site campus assignment.

For students enrolled in an HCTC 0/1 block class, EMS ISD does NOT provide transportation to the HCTC. Transportation will be provided at the end of class to student's home campus. EMS ISD will provide daily transportation between HCTC and the home campuses for students enrolled in 2/3 or 5/6 class block. Students may drive personal vehicles to and from HCTC with a signed parent/guardian transportation form and a proof of automobile insurance on file at HCTC. HCTC will issue no-cost parking passes after receiving both items. Students are not allowed to transport other students during the school day.
