Course Description

Video Production 1 is a course that will familiarize students with professional video equipment. During the course students will learn aspects of television and film production. Students will learn both Final Cut and Premiere Pro editing software along with other Adobe products. Students will get an overview of television and film history and techniques including analysis and criticism. Students in Video Production 2 will build on what they learned in Video Production 1 and will complete a film during the class year. Both classes will produce videos for the school district that will be featured in newsletters, on the website, and on the district YouTube channel.
