BOARD ROLES AND DISCRPTIONS

President - leads the organization, organize and implement goals and mission of association, calls and presides over meetings and coordinates the work of the other officers.

Vice President of Programs - coordinate programs and preside in the absence of the president.

Vice President of Fundraising - oversees all fundraising actives.

Vice President of Membership – process paperwork for new PTA members, including maintaining official lists.

Treasurer – oversees budget and finance records and manages all financial transactions, including providing reports, and filing related documents.

Secretary - records minutes of all official meetings of the association and assist in keeping records.
