There came on to be considered the returns of an election held on the 6th day of May, 2023, for the purpose of electing two members to the Board of Trustees, one for Place 6, and one for Place 7; and said returns of said election having been duly canvassed by the Board of Trustees and there being cast at said election the following votes, to-wit:

Misty Kieschnick	1,824	7



Blake Mabry, Place 7; were elected to the Board of Trustees of said School District subject to taking their oaths.


