Re: Notice of Eagle Mountain-Saginaw ISD Intent to Renew District Innovation Plan

Dear Commissioner Morath:

This firm represents the Eagle Mountain-Saginaw Independent School District ("District"). On behalf of the District, and in accordance with 19 Tex. Admin. Code §102.1313, Amendment, Rescission, or Renewal, which specifies:

- (a) A district innovation plan may be amended, rescinded, or renewed if the action is approved by a majority vote of the district-level committee established under the Tex. Educ. Code, §11.251, or a comparable committee if the district is exempt from that section, and a two-thirds majority vote of the board of trustees.

...

- (3) Renewal. During renewal, all sections of the plan and exemptions shall be reviewed and the district must follow all components outlined in §102.1307 of this title (relating to Adoption of Local Innovation Plan).
- (b) The district shall notify the commissioner of education of any actions taken pursuant to subsection (a) of this section along with the associated TEC exemptions and local approval dates.

Please be advised the District intends to renew its District of Innovation Plan ("Plan") for an additional five (5) years. The Eagle Mountain-Saginaw ISD Board of Trustees will consider and vote on whether to adopt the renewed Plan at a lawfully called Board meeting on February 28, 2022.

As specified in §102.1307(a)(1), the District's final version of the proposed Plan can be found on its website at <https://www.emsisd.com/Domain/5802>. Following adoption of the final proposed Plan pursuant to §102.1307, the District will provide TEA written notice of:


- (1) The adoption date;

- (3) The updated checklist of exemptions as provided in Figure: 19 Tex. Admin. Code §102.1307(d).
