Morning Cosmetology: Classes begin at 8:30 am – District transportation is **not** available. **Class ends at 11:27 am** - District transportation **is** available to the home campus at the end of class.

Afternoon Cosmetology: Classes begin at 1:55 pm – District transportation **is** available. **Class ends at 4:55 pm** - District transportation is **not** available to transport students at the end of class.

EMS ISD provides daily transportation between HCTC and the home campuses. Students may drive personal vehicles to and from HCTC with a signed parent/guardian transportation form and a proof of automobile insurance on file at HCTC. HCTC will issue no-cost parking passes after receiving both items. Students are **not** allowed to transport other students during the school day.
