Course Description:

In English III students will **read and understand** a wide variety of literary and informational texts... Students **write essays** with a clear controlling idea, coherent organization, and sufficient detail. Students are expected to know how to locate a range of relevant sources and evaluate, synthesize, and present ideas and information in **research**. Students will **listen and respond** to the ideas of others while contributing their own ideas in conversations and in groups. Additionally, students continue to hone the oral and written conventions of the English language in speaking and writing.

Course Goals:

Students who complete this course successfully will be able to:

• Students sharpen critical thinking skills through daily practice by analyzing in class readings, improving writing through drafting, discussing ideas, and actively listening on a variety of relevant topics. Students will also be able to effectively research a topic and synthesize information from multiple sources to then write well supported ideas on their selected topic.

Student Evaluation:

The grading system for this course is as follows:

- Grade averaged 60% Major 40% Minor
- Major grades tests (including District Common Assessments, six weeks assessments, projects, final essays, research papers, presentations); minimum three per six weeks
- Minor grades quizzes, daily assignments, journals; minimum ten per six weeks
- Semester exams will count 1/7 of the semester grade

- A letter system (S, N, U) is used to report a student's conduct based on proper/responsive conduct and citizenship
- Per Board Policy EIA (LOCAL), "The District shall permit a student who meets the criteria detailed in the grading guidelines a reasonable opportunity to redo an assignment or retake a test for which the student received a **failing** grade. This policy applies only to initial identified major grades and does not apply to daily assignments, quizzes, six-week test, and semester final examinations. Upon reteach and retest, the new test, project, etc. recorded will be a high score of 70%.

Assignments, exams, expectations outside of the classroom:

Students will be expected to complete an occasional homework assignment as well as any assignments they may not have completed during class.

- 5th Six Weeks: Research Across Informational Texts; Argument Essay
- 6th Six Weeks: Informational Texts; Multimedia Writing
