Course Description:

- English for Speakers of Other Languages (ESOL) 6, 7 and 8

This course is offered to identified English learners to help them develop proficiency in listening, speaking, reading, and writing.

Course Goals:

Students who complete this course successfully will be able to:

Understand, speak, read, and write English as quickly and as fluently as possible so they can, within a reasonable period of time, fully participate in their regular classroom programs and achieve their grade level requirements. We will work in groups, in pairs and independently, and utilize technology to achieve this goal.

Student Evaluation:

The grading system for this course is as follows:

- Grade averaged 60% Major 40% Minor
- Major grades tests (including District Common Assessments, projects, final essays, research papers, presentations); minimum three per six weeks
- Minor grades quizzes, daily assignments, journals; minimum four per six weeks
- Each six weeks will count as 1/3 of the semester grade.
- A letter system (S, N, U) is used to report a student's conduct based on proper/responsive conduct and citizenship
- Per Board Policy EIA (LOCAL), "The District shall permit a student who meets the criteria detailed in the grading guidelines a reasonable opportunity to redo an assignment or retake a test for which the student received a **failing** grade. This policy applies only to initial identified major grades and does not apply to daily assignments and quizzes. Upon reteach and retest, the new test, project, etc. recorded will be a high score of 70%.
- Official grades will be in Skyward only and can be accessed by student and parent through Family Access.
- Assignments, exams, expectations outside of the classroom:

Students are expected to independently read for at least 15 minutes each day.

Attendance/Tardy Policy/Make-Up Work: Students are expected to be in attendance every day for class. It is critical for students to be on time and engaged in their learning. 1 Tardy -Verbal Warning 2 Tardies —Phone Call Home 3 Tardies — Phone Call Home and After School Detention. All tardy students must sign-in, upon arrival to class. Parents, Guardians and students are invited to email me with any questions about missing assignments due to absences.
