Course Description:

Designed as a performance-based course, students learn fundamental instrumental techniques and music reading skills on brass, woodwind or percussion instruments. Through learning music, students are provided opportunities to: (1) perform in large and small group ensembles; (2) interact with other students and develop teamwork skills; (3) develop and increase personal and academic discipline; and (4) develop a positive self-image. ***There is a fee per student determined by each campus for this course.***

Course Goals:

Students who complete this course successfully will be able to:

1. Musically participate in all band concerts, contests, public performances
2. Learn valuable “life-skills” of discipline, teamwork, responsibility, self-confidence, social skills, time management, and critical thinking skills.
3. Students will find a social outlet that will enable learning and connections with all school classes.

Student Evaluation:

The grading system for this course is as follows:

- Grade averaged 60% Major 40% Minor
- Major grades – tests (including District Common Assessments, six weeks assessments, projects, final essays, research papers, presentations); minimum three per six weeks
- Minor grades – quizzes, daily assignments, journals; minimum four per six weeks
- Semester exams will count 1/7 of the semester grade
- A letter system (S, N, U) is used to report a student’s conduct based on proper/responsive conduct and citizenship
- Per Board Policy EIA (LOCAL), “The District shall permit a student who meets the criteria detailed in the grading guidelines a reasonable opportunity to redo an assignment or retake a test for which the student received a **failing** grade. This policy applies only to initial identified major grades and does not apply to daily assignments, quizzes, six-week test, and semester final examinations. Upon reteach and retest, the new test, project, etc. recorded will be a high score of 70%.
- Official grades will be in Skyward only and can be accessed by student and parent through Family Access.

Assignments, exams, expectations outside of the classroom:

Beginner Band students will be expected to practice 15-20 minutes every day. They will be practicing skills taught during daily classroom lessons at home to instill techniques learned during their class period. They will be expected to turn in a weekly practice log, 6-week objective sheets, and any further written assignments throughout the year. Band students are also graded on their progression in weekly playing tests, video playing assignments, placement auditions, etc.

Attendance/Tardy Policy/Make-Up Work:

Per the district as of August 13th 2020, no performances or events will be scheduled outside of the school day prior to November 1st 2020. Students are encouraged to attend school, whether participating virtually or in person, as band is a performance based class and quickly advances. Students are expected at ALL band concerts, contests, etc. outlined in our band calendar. Concerts CANNOT be made up as band is a performance-based course. Performances with an audience require live completion, which cannot be replicated in a make-up setting. Tardy policy will follow school guidelines. Make up work should be completed in a timely manner and will be assigned on a case by case basis. Communication is key.

Classroom Expectations:

Students are expected to adhere to ALL Prairie Vista classroom rules and regulations.

Preliminary Schedule of Topics, Readings, and Assignments

All classes will begin the year with music theory (the reading and writing of music). Beginner classes will begin learning instrument specific items towards the end of the first six weeks. 7th and 8th grade students will continue to refine instrumental techniques as well as review and continue building upon music theory knowledge from previous years.
