In accordance with Texas Education Code 37.105, the Eagle Mountain–Saginaw Independent School District is exercising the right to refuse you entry on to District property, or is ejecting you from property under District control. TEC 37.105 states that a person who refuses to leave peaceably when requested and either poses a substantial risk of harm to others or continued to behave in a manner that is inappropriate for a school setting can be denied entry on or ejected from property following a verbal warning from a school administrator, school resource officer, or school district peace officer. §37.107. This letter is your notice as contemplated under the Texas Penal Code.

If appropriate for the education of your child, EMS ISD shall make accommoda-

tions to ensure that you can participate in your child's admission, review, and dismissal

committee or in your child's team established under Section 504, Rehabilitation Act of

1973 (29 U.S.C. Section 794). Further, from the date of this letter, should you need to visit

Exhibit C—Website Notice Regarding the Refusal of Entry to or Ejection of an Individual from District Property

The District has the right to refuse entry to or eject a person from property under the District's control if the person refuses to leave peaceably upon request and:

- 1. The individual poses a substantial risk of harm to any person; or
- 2. The individual continues to behave in a manner inappropriate for the school setting after having received a verbal or written warning to cease the inappropriate behavior.

A person ejected from or refused entry to District property under this provision may appeal this action by filing an appeal under FNG(LOCAL) or GF(LOCAL). [See the links listed below.]
